015	The Personnel Committee noted that a national pay award is also pending, but has not yet been accepted by the national unions. The pay award being discussed is 1% April 2016 and another 1% next April 2017.				
016	Park keepers' wages were discussed and it was noted that the new minimum wage will come into effect from 1 <sup>st</sup> April 2016. Personnel Committee discussed the new minimum wage, and have decided to award this increase from April 2015.				
017	The Personnel Committee discussed the ground staff and their changing roles as other
