Annual Chairman's Report 2016

I am pleased to introduce my annual Chairman's report for Cotgrave Town Council.

It is hard to believe that a year has passed since I was newly elected to the Town Council last May. At that election I stood for a certain set of principles along with my fellow candidates from the same party. The 2 main principles were:

- 1. Carry out a review of Cotgrave Children's parks and provide a clear plan for improvement.
- 2. To stand up for Cotgrave and push for what had been promised for Cotgrave; a full and complete redevelopment of the shopping precinct.

I am pleased to say that my first point the children's park has progressed well, a working group was formed of myself, Drew Wilkie, Mick Chewings and Craig Chewings. A strategic plan was drawn up to review all parks and look at improvement over the next few years. With an immediate plan to build a brand new park at the Ring leas location, a park that has remained vacant of equipment for a long period of time. It brings me great pleasure that full funding has been secured from both the Town Council and Nottinghamshire County Council and work will start shortly on the creation of this park that will provide equipment to use for all ages, young and old and will also include an inclusive roundabout for those less abled. This is the start of the parks program within Cotgrave and I look forward to improving our recreation facilities over the next few years.

Whilst the success of the parks is good news for Cotgrave, I cannot say the same for the development of the Precinct. Within weeks of being elected to the council I took my place on the strategic board for Cotgrave during these meetings it became clear to me that although statements had been made in the past by Rushcliffe Borough Council to Cotgrave for a full and complete redevelopment of the precinct. This was far from coming to fruition. The board created plans for a complete redevelopment that would close businesses, when options were put forward to do a phased approach to ensure business continuity. Rushcliffe decided against looking into these options, choosing to showcase 2 options to the public; a refresh which allowed business continuity. Or a complete redevelopment that would close local businesses for a prolonged period. Rushcliffe had a choice for these plans and if they so wish could have presented plans for a complete redevelopment that allowed business continuity.

It also became clear that Rushcliffe Borough Council would not invest the extra money required to fulfill their promise to Cotgrave of a full and complete rebuild due to insufficient funds. Whilst at the same time they sat on a significant reserve and were pledging significant funding for a new leisure centre and civic centre in West Bridgford. I raised my concerns both in private at meetings and also in public, speaking to many members of the community and the press.

This culminated in a strategic board meeting compiling a list of facts including positive and negatives for both precinct options to be presented to Rushcliffe Borough Council cabinet to make the final decisions. It saddens me to say that at this meeting I was assured by Rushcliffe

Borough Council Chief executive Allen Graham that the presentation would be pure facts with no recommendation for either option, yet on the night itself the paper made a clear recommendation for a refurb, going against assurances made by "our partners" at Rushcliffe Borough Council.

On a positive note, I have enjoyed my time as Chairman of the Town Council meeting, different religious and community groups and local school leads. I was also pleased to see a new church form In Cotgrave; The Rock Church and have been encouraged as to their enthusiasm and participation within the community. The Town council also funded vital equipment to allow a Community First Response team to be set up with in Cotgrave to allow greater care and coverage during medical emergencies.

It has been my pleasure to be the Chairman of Cotgrave Town Council, but due to the actions of Rushcliffe and others over the Precinct I feel that I can not remain within the post. I will remain as an active Councillor for Cotgrave Town Council and will be holding them to account in the coming years and will continue to work hard for the community.

Positive Futures Update

- Callum Pharoah, of Positive Futures gave an update on the Positive Futures project work that he has completed during the previous year and the planned work up to December 2016.
- Callum started as an attendee of the project, but then became a Peer Mentor and had volunteered over 100 hours.
- Positive Futures offered him an apprenticeship ,which he accepted and started on 15th June 2015, as soon as he had completed his exams.
- Callum has completed Level 2 in Employment awareness in active leisure and learning, Gym based fitness instruction and Circuit training. Level 1 in Football coaching and is currently completing level 2 NVQ in Activity Leadership and National pool lifeguarding qualification.
- In the summer of 2015, he worked with the team and ran summer holiday activities, including ice skating, seaside and a residential trip, 61 young people attended the sessions.
- At the October half term break, 29 young people attended the youth sessions and a Halloween party was organised and well attended.
- February half term 63 young people attended the various youth sessions.
- Easter 2016, several sports sessions were well attended and a football skills programme was also ran, supported by Candleby Lane School and several young people were taken to visit Wembley Stadium.
- The apprenticeship programme involves working in different schools during the week at lunchtime and after school and helping with the young people in the gym.
- Two fitness accreditations have been completed and several more will be completed soon.

883 M748 Parkwood Leisure

884 M749 War Memorial

Councillor Shaw has attended a meeting at the War Memorial and noted that the trimming back of the trees has allowed more space and light into the immediate area surrounding the Memorial.

Placing additional paving area the existing slabs is being sourced to allow a larger standing area for the public at the War Memorial, further work is also planned.

885 M750 Letters to Police and Crime Commissioner

The grant is to be used for community projects.

Ideas for using the community fund will be discussed at the next meeting.

894 M832 Fly Tipping at Smiths Round Hill

Councillor Wilson commented that the fly tipping at Smiths Round Hill is still happening and several dogs have been injured.

Councillor Wilson asked if Rushcliffe Borough Council would offer a special collection date for removing rubbish for the residents, at a fixed cost rate.

Other Councillors suggested that residents could consider donating furniture and household goods to furniture banks used for other people to use.

The Rock Church and The Archers, part of Trent Vineyard Church, collect and restore furniture and supply household goods to people in need of help.

Councillor Butler will make enquires at Rushcliffe Borough Council, if this could be arranged.

Some larger councils offer this service at no cost to the resident. Councillors suggested will consider organising a community clean up event.

895 M839 Alleyway between Fosse Walk and Eastwold

The alleyway between Fosse Walk and Eastwold is still being used by motorbikes travelling to and from the woods.

Councillor Butler and the Clerk are arranging to meet a representative from Nottinghamshire County Council to review the area and discuss any measures, which could be placed in this area, to stop the bikes using this alleyway.

Grants Applications

- A grant application has been received from Spring Meadow Sheltered Housing Scheme asking for 50% of the funding required to purchase some 'Fit 4 Life' equipment for the local residents, to improve health and wellbeing, physical activity and community cohesion.
- The equipment to be purchased includes Kurling Stones and associated equipment, Boccia Set and Skittles at a total cost of £470.90. The request is for half the money required to purchase. The grant applied for, was for 50% of the total cost.
- Ouncil are pleased to support this application and will discuss if these activities could be offered to more local people to join in and enjoy.
- 904 **Resolved** : 'To award a grant of £235.45 to buy fitness equipment for Spring Meadow.'

Cotgrave Community Warden Service

- Otgrave Town Council employ Streetwise Environmental operatives for two hours per day, five days per week, to additional street cleaning within Cotgrave.
- The community wardens litter pick and remove dog mess from Cotgrave, from a route plan given by Cotgrave Town Council.
- The contract is due to finish on 31st July 2016. The contract if renewed, would be one year, starting from July 2016.
- Ottgrave Town Council has received less complaints regarding dog fouling and litter during the time the community wardens have been employed.
- 909 Councillor M Chewings noted that Cotgrave is looking cleaner and tidier because of the community warden service and the lengthsman scheme.
- 910 Streetwise have offered the service to Cotgrave Town Council for a third year, with no increase in the price.
- 911 The cost would be £4836+vat for the year.
- 912 Streetwise normally provide two operatives for the two hours per day.

- 937 Councillor K Chewings informed that the 'Rock Church' would like to find a project within the Cotgrave community to help with, this could be providing support for local residents helping with gardening or decorating or other projects dealing with the environment.
- Councillor Healy updated on the speedwatch team and it was noted when the team used the new equipment, supplied by the Police, only one person has continued to speed.

When the team use the handheld speed camera, at the last session, thirty drivers passed the camera doing more than 36mph in the 30mph limit. This has happened on more than one occasion.

The speedwatch team are writing to the police with this evidence, to ask for the police speed camera van to be placed in Cotgrave.

Residents have complained about speeding and it has been suggested that Hollygate Lane could have more signage to show this is now an extended 30mph area.

Another suggestion has been to consider having a crossing on Hollygate Lane, more people are using the country park and footfall will increase more residents moving into the new houses.

939 Councillor Healy mentioned that the grass around Bakers Close has not been cut and is not sure who to contact.

The Clerk will ask the ground staff to cut the grass.

Ouncillor Wilson asked if the abundance project could be suggested to the 'Rock Church', as a project for them to consider to help within the community.

The abundance project allows resident to sell or buy at a small cost or give away fruit and vegetables not required by themselves.

- Ouncillor Wilkie has noted that a car has been dumped in the carpark on Stragglesthorpe Road for some time. It has been reported to the police, DVLA and Rushcliffe Borough Council and yet it has not been removed.
- Ouncillor Healy and Wood attended the 'Future High Street' and have offered to give other councillors an overview presentation of the event on Wednesday 1st June at 7pm at Cotgrave Futures.

There being no further business the meeting ended at 9.10pm.
