- A resident, Adrian Handbury, asked if the rumours circulating Cotgrave that the precinct was not going to be changed, were true, especially as the plans in the library had stated the building work would be started in May 2017.
- 1827 Councillor Butler said that the building work will be done, but had slipped slightly behind the original plan.
- The tender for the work on the larger row of shops has been approved and the work will begin very soon, all the businesses are being informed.

- BowenWilson will not be constructing the new multi service building and the tender has gone out to other building companies and four companies have responded to the tender.
- 1830 Cotgrave Town Council has not yet been informed of which the preferred builder is. Cotgrave Town Council will ask for this information.
- Scotland Bank has been demolished and the start date of May 2017 has passed and work has not started. The project has been delayed very slightly by Rushcliffe Borough Council.
- 1832 New posters are going to be displayed in the library in August.
- 1833 The hard and soft landscape contract will go out for tender when some of the work has been completed.
- Adrian Handbury asked if the landscape plan could include an improved pedestrian access from the zebra crossing up to the shopping precinct and if the plan would be made available as soon as possible to help manage the public's expectations and stop the rumours.
- 1835 Council will ask for this information to be made available as soon as it is decided.

Progress

1837 M1750 Rebecca Clarke & Adam Sinnott

Adam Sinnott & Rebecca Clarke had been in contact to ask for further contact names for contacting the Cotgrave Welfare, to help progress their idea for future childcare provision in Cotgrave.

The Clerk had provided additional names.

1838 M1756 Parking Legislation

PCSO Evans has provided the parking legislation from the police information system and all councillors have been given a copy.

1839 M1760 Speeding on Hollygate Lane

The speedgun belonging to Cotgrave Town Council is due for calibrating and the speed watch team have not been out due to members being in holiday.

The data Councillor K Chewings needs to write to Via East Midlands asking for additional road signs, has not been available due to holidays. Speed Watch team will make the information available.

Councillor Butler informed that an interactive speed sign has been approved for Hollygate Lane and this will be fitted, but will chase up an installation date.

1840 M1762 TrentBarton

A working group meeting has been arranged to meet with Trentbarton to discuss all the changes happening to the service and all councillors have been invited to attend.

The working group will discuss all the changes that have and will affect the Cotgrave Connection service including the moving from Friar Lane to Mount Street.

The original meeting also asked to discuss the V2 service but since the request TrentBarton, will not provide the service after the 23rd July 2017. YourBus will provide a similar service but if will not cover all of the V2 route.

Councillor K Chewings demanded that this meeting should be a public meeting as noted in the minutes, which had said an Extraordinary Meeting will be called with Trentbarton and residents to discuss the future changes of bus routes and provision.

Council decided that the meeting was going to be a working group meeting and could be followed by a public meeting, if necessary, after meeting with Trentbarton, to discuss all the changes to the bus service.

- 1841 Councillor M Chewings left the meeting at 7.47pm.
- 1842 Councillor K Chewings left the meeting at 7.50pm.
- 1843 Council voted on the decision to have a working group meeting, and to have a public meeting at a future date.

All Councillors were in favour apart from Councillor Wilkie who abstained.

1844 **Resolved** : The Chairman will uphold the resolution and will arrange a meeting at a future date.

1845 M1764 Proposed Canal Bridge and Planning Application

The Clerk has contacted Rushcliffe Borough Council planning department requesting an update on any variations received from Barratts regarding removing the bridge from the original planning application.

The planning officer, Andrea Baxter, has confirmed that she has not received any new correspondence regarding changing from the original planning application or to remove the bridge from it or for any other variation.

1846 M1765 Royal Mail Letter Box on Owthorpe Road

Councillor Shaw has received a letter from Royal Mail, Collections Manager stating that a post box should be reinstated on Owthorpe Road, near the junction with Risegate, by 5th September 2017.

1847 M1769 Hopkins Solicitors

The Clerk has written to the Solicitor and requested that all the questions sent by email and verbally given by Councillors have been answered.

The Solicitor has responded and stated all the questions have been answered, and some changes to the lease have removed from the original questions.

This has held up the decision needed to be considered by Council.

1848 Councillor Shaw does not consider all the questions have been answered by the Solicitor and Councillor Shaw proposed that Council arrange an extraordinary meeting, to discuss the terms of the lease.

This was seconded by Councillor Ellis.

- 1849 Councillor Ellis suggested that a working group should prepare a financial cost benefit analysis, to decide if the cost of being in the new office was less than or equal to the cost of the current office space.
- 1850 Rushcliffe Borough Council have asked Cotgrave Town Council, to make a decision, if they are going to take the office space in the new building, by 31st July 2017.
- 1851 Cotgrave Town Council have requested that the Chairman, ask Rushcliffe Borough Council, to allow for some additional time, so a final decision can be made by September 2017.

Councillors Ellis and Shaw will meet with the Clerk to discuss all the costs for the current office and the potential costs for the new office space, if Council moved.

- 1852 **Resolved** : 'To have an Extraordinary Meeting on 24th July, to consider the financial running costs of the current and potential new office space.'
- An extraordinary meeting will be called on 20th September to make a final decision on moving into new office space, if Council are satisfied with the financial costs, if the costs are agreed at the meeting on 24th July.
- 1854 If the costs are acceptable, Council will review the potential lease and ask for further explanations of the lease.

1855 M1770 Sickness Absent

Council are very pleased that the Administration Manager has started back to work on a phased return and hope that her return to work continues well.

1856 M1779 Bank Accounts

The Clerk will organise to open the two additional bank accounts, but this has not been completed due to the HSBC account has not transferred over properly and two of the five direct debits have been refused.

Additional signatures are required for the HSBC account. The Clerk will arrange for members of Council to go to the bank, to sign the additional paperwork.

1858 M1788 Cotgrave's Future Housing Development

Councillor K Chewings had suggested forming a working group to discuss the effects of additional housing in Cotgrave and the current infrastructure and the possible future needs for the impact of erosion of rural life and additional infrastructure.

- 1859 Councillors Handbury, Shaw, Pearson, Wilkie, Brumpton, Ellis all offered to be on the working group with Councillor K Chewings.
- 1860 Councillor Wilson mentioned that Cotgrave needed to consider that some smaller properties are required to allow people to downsize or to get on the property ladder and we must beware that there is a shortage of housing.
- The working group could help to influence where any new houses could be built, if Cotgrave is chosen for some more housing.
- 1862 Councillor Butler stated that the planning display shared in March, has received many comments and Rushcliffe Borough Council are looking at all the information received, which is for the whole of Rushcliffe.
- 1863 Rushcliffe Borough Council have been informed by Local Development Framework, that some additional housing is required within Rushcliffe.
- 1864 Rushcliffe Borough Council are discussing all areas and the infrastructure they currently offer and where improvements could be accommodated.
- Rushcliffe Borough Council will have completed looking at all the areas and will be discussing which areas could be considered for additional building by late summer/early autumn.
- 1866 Councillor Butler suggests the working group arrange to meet around the same time and start to consider the options.
- Rushcliffe Borough Council has approached the planning inspectorate to relax the green belt and discuss what houses are really needed and where.
- 1868 Councillor Shaw offered to be the Chairman of the working group.

1869 M1804 Garage at Burhill Allotments

The garage alterations will be completed on 10th and 11th August and the new vehicle will be collected.

1870 M1810 Maddison Field

An article will be placed in the Cotgrave Connections and the website, to inform the public that Maddison Field can be used for dog walking, but this will be under regular review. Additional dog waste bins will be fitted.

1871 M1818 Cotgrave Country Park

A letter will be sent to Harry Burrows, to congratulate him and the team of volunteers on being voted the number one park in the area to visit.

Additional Pruning at Hawthorne Avenue.

The Clerk suggested that Council consider removing some of the trees from this area and pruning back the larger ones, to help reduce ongoing costs.

The Clerk will get a quote from the tree surgeon, who is coming to do some pre-arranged work on 1st August and send the costs to Council for consideration.
